CUC Ovens Murray (CUC-OM) was formally established in February 2021 through the enormous efforts of individuals and agencies within our region with the aim to ensure that a new model of equitable and locally accessible university education delivery could occur across the three geographical sites of Wangaratta, Mansfield and Corryong.

This vision is being realised with an increasing number of graduates who have utilised the CUC throughout their entire degrees, many of whom have now joined our local workforce in professional roles in the health and education sectors and other hard to fill professional roles. This is providing regional uplift in our local economy and social capital, and is a key benefit for our communities in having a CUC in our midst.

We continue to build on and formalise our key partnerships at each of our locations to enable and support the Centres: Rural City of Wangaratta (RCOW) and GOTAFE; Mansfield Adult Community Education (MACE); Towong Shire for the facility and Snowy Hydro for their sponsorship in Corryong. The 'Grow our Own' partnership with RCOW is now considering the role of CUC as a part of the solution to the professional skill shortages in our community.

Finally, I wish to acknowledge the professionalism of Centre Manager, Mark van Bergen. Mark's passion for education and advocacy for our students ensures that all those who come into our centre are supported to overcome any obstacles and barriers to their completion of studies. Ovens Murray success is recognised by being sought to provide advice to incoming Centre Managers at new CUCs, and to pilot CUC Central initiatives – such as developing the risk framework standards workshop package for CUC boards.

Mark and the team have supported more students than ever before to complete their studies here in the Ovens Murray.

I'm delighted to reflect on the significant achievements and progress that CUC Ovens Murray has made in 2025.

At the end of Semester One 2025, we registered our largest cohort yet with 247 students accessing our services. This figure was a 40% increase on Semester One in 2024, and also means we have now surpassed over 450 students supported since our inception.

The staff team across our Corryong,
Mansfield and Wangaratta locations is
highly skilled and stable. The fantastic
results and comments in our Student
Experience Survey and our record
number of Learning Skills Advisor sessions
in 2025 highlight the positive impact our
staff can make to regional students
higher education journey.

The completion of the refurbishment of the Wangaratta facility marks a significant moment in the CUC Ovens Murray story and our partnership with GOTAFE. Improvements were also made to the student learning space in Mansfield and the connectivity at our Corryong site.

Our 'Peak Pathways' program, which has been co-designed with local schools, RMIT and La Trobe Universities has now been piloted, developed and rolled out to 15 schools across our region. The program and partnership continues to grow and is a key pillar in our efforts to widen participation in higher education in the Ovens Murray. Recruitment of CUC-OM Student Ambassadors to help deliver the activities has become a real strength of the program.

Our community engagement continues to grow, as more and more people become aware of our organisation. We now have the 'runs on the board' when it comes to the positive impact CUC Ovens Murray has in the region.

Finally, thank you to the CUC Ovens Murray Board for your support and guidance. The organisation is in a terrific position and has achieved a great deal since opening in 2022.



The Country Universities Centre began with the establishment of the Cooma Universities Centre in 2013, created to offer enhanced. supported higher education opportunities in the regional town of Cooma, home to around 7,000 people.

CUC Ovens Murray is supported by MACE with a dedicated space within their Mansfield facility.

Towong Shire Council

Three modular buildings at the Corryong Innovation Space are provided by the Towong Shire Council to accommodate CUC Ovens Murray.

La Trobe and RMIT Universities

CUC Ovens Murray has partnered with these two universities to design and deliver our 'Peak Pathways' - Widening Participation program to schools across our region.

Community Jovernment arthership

Our community are our biggest supporters. The Centre has engaged with local industry, schools, and organisations. The success of this Centre depends on the support from our local community.

Local Schools

In 2025, CUC Ovens Murray has increased the number of schools involved with our Peak Pathways program to 15 schools across the region, delivering 85 sessions to 1071 students.

CUC Ovens Murray organised and delivered Mansfield's first careers Expo with over 20 exhibitors and 220+ people attending.



Local Organisations

CUC Ovens Murray continues to build connections and partnerships across the region. A Memorandum of Understanding was signed with the Rural City of Wangaratta in 2025. CUC-OM has worked on collaborative projects across our three communities and been present at many community events.

Local People

Our registered students are our greatest ambassadors. We have seen a 60% increase in the number of students registered with CUC Ovens Murray over the last 12 months. We have grown our students ambassador program numbers and are a key part of our Peak Pathways program delivered in schools.

Here For Our Students

With the support of their local CUC regional, rural and remote students can follow their dreams when it comes to study. The CUC has responded to student needs and created an innovative model that allows choice by supporting any student, studying any course, at any Australian Tertiary Education Provider.


The wrap-around model of student services provides face-to-face academic, wellbeing, technology, administrative support in a learning community in addition to what each student's university already provides. These extra layers of support are crucial for many students who study with the CUC.

Regional students are often at greater risk of attrition. Many students are from low SES backgrounds, are the first in their family to attend university, or have caring responsibilities and multiple other commitments. The CUC offers a free, safe and welcoming environment to study with flexible and personalised face-to-face support. The CUC understand that students are individuals that need a variety of services to meet their needs so that we meet students where they are in their education journey.

CUC Ovens Murray supports students at all our sites, with the provision of Education Coordinators at Mansfield and Corryong, and a Student Services and Engagement Coordinator at Wangaratta. The Centre Manager and Centre Administrator support students across all three sites. Learning Skills Advisors are employed at each site, offering workshops and one-on-one academic support to students.

Wangaratta Refurbishment

The Wangaratta facility refurbishment was completed and officially reopened on 6th December 2024. The Centre was redesigned to incorporate more usable spaces for our students and exceeded many students expectations, which has led to a significant increase in registrations.

Peak Pathways

The program, which consists of four activities to inform aspirations of students in upper primary/lower secondary, has been finalised, produced and delivered to 14 schools across the Ovens Murray in 2024/25. The partnership with La Trobe and RMIT universities continues to grow, with enrichment activities being trialed with schools.




More registered students

2025 SNAPSHOT







The intensive course was run over 2 years with most of the content delivered remotely with weekend residential schools once per 8 week block. The CUC was a godsend providing a place for him to access the resources he needed to complete his study around his part time work hours.

After retirement, Phillip decided to study for an arts degree, something he had wanted to accomplish. He commenced his studies with the University of New England and then transferred to the University of Tasmania to complete a Diploma in Family History. Following this success, he then commenced with a Bachelor of Arts Degree, majoring in history.

Phillip completed some of his subjects for his degree through other universities including Deakin, where he studied The Holocaust, Macquarie University studying the First World War and Charles Sturt University studying the English Reformation which resulted in the formation of Protestant churches. All of Phillip's units were completed online and he regularly accessed the facilities and services of CUC Ovens Murray during his studies, he stated "...there is good support for this type of study, I recommend people of all ages to investigate options available and begin studying."

Alicia was one of the first people to register with CUC Ovens Murray when it opened in early 2022. At the time, Alicia was studying an Honours of Psychology, online, through Deakin University. She completed a randomised control trial with her research being published. Alicia was then accepted into the Masters of Professional Psychology at La Trobe University (online) where she continued to use CUC Ovens Murray to complete her studies, before undertaking her year long internship placement in Wangaratta.

All of Alicia's subjects were completed online and she regularly accessed the facilities and services of CUC Ovens

Murray during her studies, she stated "...having access to the CUC, meant that I didn't have to worry about internet speed and stability, and access to an exam suitable location also alleviated stress. The CUC also provided me with a sense of community."

"Study is a solitary endeavour, but for me the presence of others undertaking their own similar journey was a comfort and frequent support. The CUC allowed me to meet others who were similarly focused on clearing the next hurdle requirement, dissecting rubrics, scouring sources and going cross-eyed over reference formatting."



Note 1. Summary of material accounting policies

CUC Ovens Murray Ltd (the Company) is a not-for-profit company limited by guarantee, incorporated and domiciled in Australia.

(a) Basis of accounting

In the Board of Director's opinion, the Company is not a reporting entity because there are no users dependent on general purpose financial statements.

These special purpose financial statements that have been prepared for the sole purpose of complying with the requirements of the *Australian Charities and Not for Profits Commission Act 2012* to prepare and distribute financial statements to the members and must not be used for any other purpose. The directors have determined that the accounting policies adopted are appropriate to meet the needs of the members.

Under AIFRS, there are requirements that apply specifically to not-for-profit entities that are not consistent with International Reporting Standards (IFRS) requirements. The entity has analysed its purpose, objectives and operating philosophy and determined that it does not have profit generation as a prime objective. Consequently, where appropriate the Company has elected to apply options and exemptions within the AIFRS which are applicable to not-for-profit entities.

The financial statements have been prepared in accordance with applicable Australian Accounting Standards, Australian Accounting Interpretations and other authoritative pronouncements with the exception of the following:

AASB 7 - Financial Instruments - Disclosures

AASB 9 - Financial Instruments

AASB 15 - Revenue from Contracts with Customers

AASB 16 - Leases

AASB 119 - Employee Benefits

AASB 124 - Related Party Disclosures

AASB 1058 - Income for Not-for-Profit-Entities

The financial statements are prepared in accordance with the historical cost convention. Unless otherwise stated, the accounting policies adopted are consistent with those of the previous year. Comparative information has been reclassified where appropriate to enhance comparability.

(b) Income

(i) Grant income

Grant funding is recognised as income when the Company obtains control over the granted asset. Control over granted asset occurs at the earlier of receipt or when the company is deemed to have established a right to receipt.

(ii) UNE & Universities partnerships and sponsorship income UNE & Universities partnerships and sponsorship income is recognised as income upon receipt

(iii) Other income

Other income, including exams fees, is recognised as income upon provision of the related services.

(iv) Interest

Interest income is recognised on an accrual basis taking into account the interest rates applicable to the financial assets.

Notes to and forming part of the financial statements

Note 1. Summary of material accounting policies (continued)

(c) Income tax

Income tax is not provided for in the financial statements as the Company is recognised as tax exempt under the Income Tax Assessment Act and therefore not subject to tax.

(d) Property, plant & equipment

All items of property, plant and equipment are stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Capital works in progress is not depreciated. Depreciation on other assets has been calculated on a straight-line basis in order to write off the cost of assets over their expected useful lives. Estimates of remaining useful lives are made on a regular basis for all assets. The expected useful lives are as follows:

Office fit out Plant & Equipment

25 years 4 - 10 years

An asset's carrying amount is written down immediately to its recoverable amount if the assets carrying amount exceeds its estimated recoverable amount.

(e) Provisions for employee entitlements

(i) Annual leave

A liability for annual leave is recognised and measured as the amount unpaid at the reporting date at current wage rates, plus on-costs, in respect to employees' service up to that date.

(ii) Long Service Leave

A liability for long service leave is recognised and measured for only those employees who have attained 5 years' service with the Company, based on amounts unpaid at the reporting date at current wage rates, plus on-costs, for services provided up to that date.

(f) Leases

Lease costs are expensed in the period to which they relate.

(g) Comparative Figures

Where required by Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.
